- the current update launched in 2017 or studied for a new qualification since September 2017 will have to attend the FINA Rules update from 2017 before they can renew their licence. There is only one official in this category in Dorset and they will be offered a 1-2-1 opportunity should they wish to re-licence.
- The mandatory requirement for J1 trainees to attend a L1 or L2 meet during their J1 practical training has been removed. Instead, if they wish to go on to study for J2, they will need to attend a L1/L2 meet as part of their 20 post experience hours before being able to enrol on J2.
- The "Afro" hat is now an accepted swim hat in all competitions.
- Certificates of Exemption replacing Certificates of Disability are being seen on poolside. They should be accepted without question.
- PMN: L1/L2 meet applications must now include confirmation of the availability
 of a strobe which should be asked for at the time a swimmer makes their entry
 to a competition and should be provided (unless documented circumstances
 prevent this). Meets at L1/L2 must have a minimum water depth of 1.35m.
