From January 2024 all clubs will also be required to submit a DIAP (Diversity and Inclusion Action Plan).
- 2. Swim England: New Safeguarding CPD ('Mobile Devices in the Sport Setting') available for those who have completed the full SE f-to-f or online course. Complete list of CPD modules can be found at swimenglandqualfications.com/cpds.
- 3. Swim England SWR: County Development Day 7 January 2024; R Honeybun, G Griffin, and Mrs J Beard to attend on behalf of Dorset.

Lead Coach Martin Littlefair (Seagulls), Coach Mentor/Team Manager Barry Alldrick (Poole), Skills Coaches Eve Goldsack (Seagulls), Mark Freeman (Blandford), Phil Looker (Poole) and Trish Goodrick (Weymouth). Change to 12-year-old age group following a Relative Age Effects Study.
- 6. DCASA: Swimming Coach course (L2) taking place Oct/Nov 2023 in-county with practical sessions at Talbot Heath School; 13 Dorset candidates from eight clubs participating.
